### What is this product?

Type: European corporate investment grade bond, income accumulation

Objectives: The Fund aims to increase the value of the invested capital over time and to generate income. The Fund is actively managed and invests mainly in bonds, debt securities and credit instruments. For the purpose of calculating the performance fee, the Fund uses a benchmark consisting of the following index

- ICE BofAML Euro Corporate.

The Fund does not seek to replicate the composition of the benchmark; it therefore also invests in financial instruments not present in the index or present in different proportions.

Investment Policy: The Fund invests mainly in bonds, debt securities and credit instruments issued by companies of any sector and more than 50% of its assets in "investment grade" credit instruments. In particular, the Fund may:

- invest in instruments denominated in currencies other than the Euro;
- invest, residually, in money market instruments with a duration of less than 12 months and hold liquid assets, including bank
- invest up to 10% of its assets in unlisted securities and up to 10% in Undertakings for Collective Investment in Transferable Securities (UCITS) or Undertakings for Collective Investment (UCIs);
- use derivatives not only for hedging purposes, such as forward foreign exchange transactions, futures, options, swaps and contracts for differences.

The Fund's investment decisions are made on a discretionary basis. The value of the Fund is calculated and expressed in Euros. Redemption of units: The frequency of partial or total redemption of units held by unitholders is aligned with the frequency of calculation of the unit value of the unit, which is determined on a daily basis, except on days when national stock exchanges are closed and on national holidays, when national stock exchanges are also open.

Maturity: The Fund is established without limits of duration

Intended retail investor: The Fund is aimed at a retail client with an adequate level of theoretical knowledge and financial experience, who has the ability to withstand potentially high financial losses and who aims to obtain growth in the capital invested, over a recommended time horizon of at least 2 to 5 years, consistent with the level of risk assumed. According to the Rules, the Fund may be subscribed for an amount, net of subscription charges and expenses, of not less than EUR 2,500.

# What are the risks and what could I get in return?

# What happens if Ersel Gestion Internationale S.A. is unable to pay out?

The assets of the Fund are held in safekeeping by its Depositary, CACEIS Bank Luxembourg Branch. However, in the event of the insolvency of the Depositary or a delegate thereof, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations.



#### What are the costs?

### How long should I hold it and can take money out early?

#### Recommended holding period: 5 years
